You will earn an additional \$100 if three or more of your WS results are in the healthy range or if you complete four telephonic coaching sessions by November 30, 2017. If you complete the WS in a physician's office, the doctor must fill in and mail or fax the Healthy Living physician form with your results to Healthyroads.
